How much oil does SEPLAT produce a day?

SEPLAT subsequently grew oil production to a peak rate of 85,200 barrels (13,550 m³) of oil per day and had almost doubled its remaining reserves at the end of 2015. In June 2013, SEPLAT acquired an interest in the Umuseti/Igbuku marginal field area within OPL 283 and in February 2015 acquired interests in OML 53 and OML 55.
