

What is the health system in Bosnia and Herzegovina?

Bosnia and Herzegovina consists of two entities (the Federation of Bosnia and Herzegovina and the Republika Srpska) and one autonomous district (the Brčko District of Bosnia and Herzegovina), and has complex health systems, with 13 health insurance funds and 14 ministries in charge of health.

How does health insurance work in Bosnia & Herzegovina?

The main source of public funds for the health systems of Bosnia and Herzegovina is mandatory health insurance contributions collected and pooled at entity/district or canton level. The benefits packages are relatively comprehensive, but coverage is not universal and entitlements are not harmonized across health systems.

How many cantons are there in Bosnia & Herzegovina?

The Federation of Bosnia and Herzegovina is further divided into 10 cantons, each of which is governed by its own cantonal government. This structure results in a complex health system with 13 health insurance funds and 14 ministries responsible for health.
