

Why is Burkina Faso reliant on energy imports?

Burkina Faso's economy is heavily reliant on energy imports. In 2013, 92% of the country's electricity was imported or produced from imported oil and the country's economy is particularly vulnerable to fluctuations in the price of oil. Burkina Faso is simultaneously facing challenges of energy access, energy security and climate change mitigation.

Does Burkina Faso have a franc?

Burkina Faso is part of the West African Monetary and Economic Union (UMEOA) and has thus adopted the CFA Franc, which is issued by the Central Bank of the West African States (BCEAO), situated in Dakar, Senegal. There is mining of copper, iron, manganese, gold, cassiterite (tin ore), and phosphates.

Burkina Faso, also known by its short-form name Burkina, is a landlocked country in West Africa around 274,200 square kilometres (105,900 sq mi) in size.

What challenges does Burkina Faso face?

Burkina Faso is simultaneously facing challenges of energy access, energy security and climate change mitigation. With no growth in electrification rates over the last few years, less than 5% of the rural population have access to electricity and many schools and hospitals lack supply.
