

Is Cambodia a member of the WTO?

Cambodia is a member of WTO since 2004 and, as a least developed country, benefits from the European Union's Everything But Arms scheme, which grants unilateral duty free, quota free access for all exports, except arms and ammunition.

What is the trade between the EU and Cambodia?

See Legal Act and Memo. In 2023, total trade in goods between the EU and Cambodia equalled EUR 5.8 billion. In 2023, the EU ranked as Cambodia's fourth-biggest trade partner, accounting for 8.2% of the country's total trade (with China at 25.8%, the United States at 19.3%, and Vietnam at 13.9%).

Why did the European Commission withdraw a trade agreement with Cambodia?

On 12 February 2020, the European Commission decided to withdraw part of the tariff preferences granted to Cambodia under the EU's Everything But Arms (EBA) trade arrangement due to serious and systematic violations of the human rights principles enshrined in the International Covenant on Civil and Political Rights.
