

How can Bess provide ancillary services?

The evolution of the power system requires reliable and rapid control of frequency deviation. BESS can provide very quick ancillary services; however, their limited energy reservoir must be taken into account when providing these services. This can be done by defining innovative requirements that implement degrees of freedom for SoC management.

Can Bess provide short-term and long-term ancillary services in power distribution grids?

Are ancillary services necessary?

As previously mentioned, ancillary services (FCR included) are essential for the safe management of the electric system. For this reason, TSOs can ask the BSP not (or partially) correctly providing the required service to pay a penalty.

Does Bess affect the MV distribution system?

In this paper, the impact evaluation of the BESS on the MV distribution system has been studied for ETS and FR applications. ETS operation is based on the feeder load profile and FR is based on grid frequency variation.
