

Who owns Kronos solar EDPR?

Madrid, 14 June 2023. Kronos Solar EDPR, a solar developer company based in Germany that is majority owned by EDPR, has signed a long-term PPA with Google to offtake part of the production of clean energy by four photovoltaic plants that Kronos Solar EDPR is developing in The Netherlands.
