

When will goulamina lithium concentrate be produced in Mali?

The Goulamina lithium project in Mali is well into a 27-month development programme that will see first concentrate production in H1,2024.

What does Leo lithium do for Corica Mali?

Leo Lithium has awarded a \$348-million openpit mining services contract to Corica Mali for operations at the Goulamina mine. The contract encompasses six months of preproduction activities at Goulamina followed by a fixed five-year term. The scope of the contract comprises grade control,drill-and-blast,load-and-haul,and plant ore feed services.

What is the goulamina Lithium Project?

The Goulamina Lithium Project (Goulamina) is a spodumene project with development underway,located 50km west of Bougouni in Mali with all approvals and key permits received to bring the project into production. An updated Definitive Feasibility study (DFS) was completed in December 2021.

Where does lithium come from?

Lithium is found in various naturally occurring sources,including brine deposits,hard rock minerals such as spodumene and petalite,and clay deposits. A 50/50 joint venture with Leo Lithium and Ganfeng,the Goulamina Lithium Project in Mali is West Africa's first spodumene producer to supply the booming lithium-ion battery industry.

Is Hainan mining launching a new battery-grade lithium hydroxide processing plant?

In August 2021,Hainan Mining announced the proposed investment of 1.065 billion yuan (\$164 million)to develop a new processing plant to make battery-grade lithium hydroxide as a starting point of its move into the lithium sector,supporting the booming demand in the EV sector.
