

Who is Optimera energy?

Optimera Energy is a consortium made up of Falcon Corporation Limited, FHN Gas Limited, and ND Western Midstream Limited (the "Consortium"). The Consortium has been formed in 2022 to play major part in Nigeria's energy transition with particular focus by developing and executing gas distribution.

How much wind power does Morocco have?

Total installed capacity from solar energy currently stands at 831 MW. According to the Ministry of Energy Transition, and Sustainable Development, Morocco could potentially generate 25,000 MW of wind power. At present, Morocco has an installed capacity from wind energy of 1553 MW, the second largest volume in Africa behind South Africa.

What is Morocco's strategic focus on natural gas?

Morocco's strategic focus on natural gas is articulated through a domestic roadmap, the Natural Gas roadmap that was launched in 2021 and covers the period 2021-2050, aims to create a regulated market that stimulates evolving demand.
