Nala Renewables has entered an agreement to acquire a 61MWp [megawatts peak] solar photovoltaic (PV) project in western Romania from renewable energy group Monsson. The solar project will begin construction in the third quarter of this year and is expected to be connected to the Romanian power grid by 2025.

OX2 has closed an agreement to sell a 99.2 MW onshore wind project in Romania to Nala Renewables, a joint venture between IFM Investors and Trafigura. The agreement includes construction of the wind farm, and the contract value is 2.48 billion SEK.
