

Is there a shortage of solar installers in Sweden?

Skill shortage: There is a shortage of trained installers, which could slow down the pace of solar energy adoption and implementation of renewable energy projects. Sweden has already reached its solar target in the current NECPs in force of 2.2 GW and has established a new target in its draft revised NECPs of 6.6 GW, 119% higher.

Should solar parks be developed in Sweden?

There is huge potential to develop solar parks on the Swedish market, where large spaces can contribute to the energy transition, and where battery technology creates stability in the electricity system. Solar parks call for permits and various kinds of environmental consideration, both for wildlife and when it comes to food production.

How much solar is installed in Sweden in 2022?

The installation rate of PV continues to increase rapidly in Sweden, particularly rooftop and domestic ones. In 2022, a total of 796.6 MW of grid-connected solar capacity was added, which means a 59% market growth compared to the 499.7 MW installed in 2021.

Self-consumption or known as SELCO applies when electricity is being generated for own usage and any excess is not allowed to be exported to the grid. The Government is encouraging individual, commercial and industrial consumers to install solar PV for their own consumption, looking to hedge against the rising cost of electricity.

CO2 Avoidance. As electricity generation from renewable resources displaces the generation of power from conventional fossil fuels, the generation of RE therefore reduces the overall greenhouse gas emissions from the fossil fuel power stations connected to the grid system.
