

Who owns Senelec & GE?

The Senegalese state-owned power utility Senelec and the independent power producer West Africa Energy (15% owned by Senelec) have signed an engineering, procurement and construction (EPC) contract with GE and the Turkish group Calik Enerji to build a 300 MW gas-fired power plant in Cap des Biches, near Rufisque.

Will Senegal convert its coal-fired power plants to gas?

Since its offshore gas fields are planned to come on stream in the next few years, Senegal plans to convert its coal-fired and oil-fired power plants to gas over the next years. The government expects this fuel conversion to help reduce power generation costs and end-consumer prices.
