Seychelles has almost universal access to electricity (99.54 %), but ageing and unreliable energy infrastructure is reducing energy efficiency. The country is heavily dependent on imported fuel for power generation which continues to make Seychelles extremely vulnerable to fluctuations in global fuel prices.

In the past three years, the Seychelles has increased its installed solar PV capacity more than fivefold to 12MWp, or around 4% of national power demand, saving millions of dollars in liquid fuel imports in the process.
