

Where can I get solar power in Zimbabwe?

The government is hoping to maintain policies that will encourage more investors in the future. By the end of 2020, Zimbabwe has reached 17 MW capacity in solar installations. They are targeting to reach 1GW of capacity by 2025. As of now, there are limited options for suppliers and distributors within Zimbabwe.

Where can solar energy be used in Africa?

In agriculture, the Dube TradePort IDZ in Durban, the Cape Span and the Rooibos Ltd. plants in the Western Cape where solar electricity is used to provide renewable energy in the production of agricultural supplies with lowered carbon emissions.
