Saint Lucia is a small island developing state located in the Eastern Caribbean with a population of approximately 170,000 people (USDS, 2010). St. Lucia is classified as a middle-income Small Island Developing State. It is of relatively recent volcanic origin with a rugged topography. It sits on an ancient volcanic ridge connecting Martinique to the north and St. Vincent to the south.
