

Does Timor-Leste provide backstop guarantee for EDTL obligations?

For the Solar IPP project, Government of Timor-Leste represented by the Ministry of Finance has provided backstop guarantee for EDTL obligations under the Implementation Agreement. Special Investment Agreement, if concluded could allow the winning bidder a leasing of the Site at a concessional rate and other benefits.

What is Timor-Leste's energy policy?

The government of "Timor-Leste" is also trying to shift its policy to the introduction of clean energy, such as hydraulic, wind, and solar power generation. However, the most of its national budget for the electric power sector are spent on fuel import and electricity charges, so it is difficult to realize its policy.

Does Timor-Leste need a strategic development plan?

Over the last decade, development in Timor-Leste has been guided by the Strategic Development Plan (SDP) 2011-2030, which aims to make Timor-Leste an upper middle-income country by 2030. SDP covers three key areas: social capital, infrastructure development, and economic development as the pillars to drive the country forward.

Who is responsible for implementing a Timor-Leste project?

(1) Implementation System The competent authority of this Project is the Secretary of State for Energy Policy of "Timor-Leste", and the executive agency is the Ministry of Education. Note that the Ministry of Finance takes charge of actions for tax exemption etc. in cooperation with the Secretary of State for Energy Policy.

Will Timor-Leste replace oil imports with solar power?

More than 75% of oil imports in Timor-Leste are used for electricity production across the country and around 90% of the sector's operating costs are fuel costs associated with power generation. The Government of Timor-Leste intends to replace part of this high-cost generation by more cost-efficient solar power.

What is Timor-Leste project?
