

Who is Uniper energy storage?

Uniper SE is a German multinational energy company based in Düsseldorf, Germany, which has been a state-owned enterprise since late 2022. It is one of the biggest energy companies by revenue in Europe. [1] The name of the company is a portmanteau of "unique" and "performance", [2] which was given by long-term employee Gregor Recke. Is Uniper a holding company?

The company became active on 1 January 2016, with 14,000 employees and is expecting an operating profit (EBITDA) of EUR4 billion.
