France-headquartered independent power producer (IPP) Voltalia has started building a 126MW solar PV project in Uzbekistan, to which it will add a 50MW/100MWh battery energy storage system (BESS) with plans to build another project ten times as big.

Work is underway on 12 projects to build green stations and energy storage systems with companies from Saudi Arabia, the UAE, China, France, and Switzerland. At today's meeting, the tasks for the full completion in 2024 of projects that began last year and plans for creating new green generation capacities in the coming years were discussed.
