

Who is Vivo Energy?

Vivo Energy is a Shell and Engen Petroleum licensee and sources, distributes, markets and supplies fuels and lubricants. It was listed on the London Stock Exchange and the Johannesburg Stock Exchange and was a constituent of the FTSE 250 Index and of the JSE All Share Index until it was acquired by Vitol Group in July 2022.

What is Vivo Energy Namibia?

Vivo Energy Namibia, established in 2012, is a leading fuel and lubricants supplier in Namibia. It distributes and markets Shell-branded fuels and lubricants in the country. Today, Vivo Energy Namibia supplies many of the country's major mines, has service stations in strategic locations, runs a nationwide depot network, and is considered one of the market's leading fuel and lubricants suppliers.

Which countries joined Vivo Energy?

Cape Verde, Senegal, Madagascar, Mali, Mauritius, Morocco, Tunisia joined Vivo Energy in December 2011. They were followed by Burkina Faso, Côte d'Ivoire, Guinea in February 2012; Botswana and Namibia in October 2012; Kenya in November 2012; Uganda in February 2013, Ghana in August 2013 and Mozambique in August 2013.

Does Vitol own Vivo Energy?

Vitol, through a newly formed indirect subsidiary called BidCo, is acquiring the shares of Vivo Energy it does not currently own. The transaction is valued at USD2.3 billion at USD1.85 in cash for each Vivo share. Vitol had a 36% stake in Vivo Energy prior to this transaction.
