

Does Wallis & Futuna benefit from the energy equalisation scheme?

The remoteness and isolation of the archipelago does not favour the development of the tourism sector. Since July 2016, Wallis and Futuna has benefited from the Energy Equalisation scheme. It establishes a progressive alignment of the local electricity tariff with that of France.

Where is Wallis & Futuna located?

Wallis and Futuna, officially the Territory of the Wallis and Futuna Islands [A] [3] (/ 'wʔlʔs ... fu:'tu:nʔ /), is a French island collectivity in the South Pacific, situated between Tuvalu to the northwest, Fiji to the southwest, Tonga to the southeast, Samoa to the east, and Tokelau to the northeast. Mata Utu is its capital and largest city.

How does Wallis & Futuna generate income?

Wallis and Futuna generates income through its representation in the French political system, electing one senator to the French Senate and one deputy to the French National Assembly. The territory's economy is primarily based on traditional subsistence agriculture, with about 80% of the labor force earning its livelihood from agriculture (coconuts and vegetables), livestock (mostly pigs), and fishing.

How is Wallis and Futuna governed?

As a territory of France, Wallis and Futuna is governed under the French constitution, uses the French legal system, and suffrage is universal for those over 18 years of age. The French president is elected by popular vote for a five-year term.

What is the difference between Wallis and Futuna?

Wallis is surrounded by islets scattered inside the lagoon and Futuna, which is not near the lagoon, has only one islet that is much larger than those of Wallis. Unlike Wallis that has a low relief (highest point 151 m), Futuna and Alofi are high volcanic islands (highest point 524 m).

What is the economy type of Wallis & Futuna?

Wallis and Futuna have a subsistence-based economy. The land produces taro, yams, sweet potatoes, cassava, and breadfruit. There are no local sales of foods, except to foreigners. The nuns teach cooking and how to use new foods. Remittances are paid from expatriate workers in New Caledonia.

A wet day is one with at least 0.04 inches of liquid or liquid-equivalent precipitation. The chance of wet days in Wallis and Futuna varies significantly throughout the year. The wetter season lasts 8.2 months, from September 29 to June 4, with a greater than 41% chance of a given day being a wet day. The Census is the official count of population, household and dwellings in Wallis & Futuna and it gives a general overview of the country at one specific point in time: 23rd of July 2018. Since 1969 until 2003, Census has been taken once in every 7 or 6 years and every 5 years from 2003.

In 1991, BNP Nouvelle-Calédonie, a subsidiary of BNP Paribas, established a subsidiary, Banque de Wallis-et-Futuna, in the territory. Two years earlier Banque Indosuez had closed its branch at Mata-Utu, leaving the territory without any bank. Following this, the Bank of Wallis-and-Futuna (BWF) with its head office in Wallis was created in 1991.

CFP coins are in denominations of 5, 10, 20, 50, 100, and 200 francs, ...

Thus, Futuna is subjected to periodic earthquakes, the most recent occurring in March of 1993. The topography is more pronounced than on Wallis, with hills rising to 524 m / 1,719 ft. (Mt. Puke on Futuna) and

417 m / 1,368 ft. (Mt. Kolofau on Alofi). Alofi was inhabited until around 1840, but was abandoned because of a shortage of water.
